

The area has very favourable demographics - the 2020 average household income within 1 kilometre radius of 417 Spadina Road was \$266,339, over 60% higher than Toronto's average household income of \$98,174.

The area has dedicated bike lanes, street parking and access to the St. Clair Street car line and numerous bus lines that makes getting to and from it by car, bike or public transport easy.







#### Unit A | Second + Third Floor | Spadina Road Entrance


#### Unit B | Ground Floor | Lonsdale Road Entrance


