



## The Cocation

1051 Bloor Street West is located in Bloorcourt Village, a popular retail and restaurant strip located along Bloor West between Montrose Avenue and Dufferin Street. Bloorcourt is known for it's great variety of shops and restaurants and its annual "Sidewalk Sale and Community Festival". Popular neighbourhood retailers and restaurants include Makers Pizza, Cafe Paradise, Station Cafe and Kitchen, Osteria Rialto Long & McQuade, Gus Tacos and many more.

Just west of the Property is the Bloor & Dufferin development site, which consists of six mixed-use residential buildings and greenspace. The project will feature 2,034 new residential units, 74,893 sq. ft. of retail and 38,540 sq. ft. of greenspace.

The Property benefits from its close proximity to Christie Pits Park, one of Toronto's most popular urban parks. The park is a huge draw to the area, especially in the summer months, where people flock to the park to swim in the public pool, play sports or walk their dogs.

1051 Bloor Street West is ideally serviced by the Bloor-Danforth subway line and is within walking distance to both Dufferin Station and Ossington Station.














### **Bloor Street West - Neighbouring Tenants**
