




Floor Plans



The Location




385 Queen Street West is located in the heart of one of Canada's most prominent retail hubs, Queen Street West.

Queen West is known for it's mix of trendy fashion boutiques and premium international brands including Reigning Champ, Club Monaco, Aritzia, Zara, Lululemon, MAC, Fjällräven and many more.

Queen West's central location in Downtown Toronto, along with the significant residential/employment growth in the immediate area, allows the node to continue it's ability to attract premium retail brands, restaurants and bars creating significant pedestrian traffic seven days week.

TRANSIT CONNECTIVITY AND ACCESS












Nestled just steps from the forthcoming Queen-Spadina station on the future Ontario Line, this prime location takes advantage of the 15.6 km subway line which will span from Exhibition Place through the heart of downtown Toronto, extending northward to Eglinton at the Toronto Science Centre. This new line will directly connect 385 Queen to Toronto's current subway system as well as numerous GO stations, various streetcar lines and bus lines and the Eglinton Crosstown LRT.



Furthermore, the Property's accessibility is already remarkable with a short walk to the existing Osgoode subway station on the Yonge-University Line, direct adjacency to the 501 Queen streetcar line, and mere seconds from the 510 Spadina line.


